The basis of concluding the contract: **General Terms and Conditions of the Civil Liability Insurance of a Road Carrier in the International Traffic, dated 01.01.2016 (TM/OW026/1601)**

Subject and scope of the insurance:

civil liability of the carrier in Road transport for the following losses arose during the insurance period: the entire or part of the commodity being lost or damaged during the course of an international truckage, for which the Policy Holder is liable according to the provisions of the Convention on the Contract for the International Carriage of Goods by Road (later referred to as CMR), subject to the exclusions mentioned in the General Terms and Conditions of the insurance

Limit of indemnity: **400 000.00 EUR**
Franchise: deductible for every loss for the below listed clauses: 400 EUR, for remaining types of losses: 200 EUR, unless stated differently for particular scopes of the insurance

The scope of the insurance is extended to include the following clauses:

- Clause 01: Inclusion of Road Carrier's Liability Insurance for the transportation of ADR materials
- deductible franchise for every occurrence: 280 EUR
- Clause 02A: Inclusion of Road Carrier's Liability Insurance for the transportation of household appliances
- Clause 02B: Inclusion of Road Carrier's Liability Insurance for the transportation of Hi-Fi Audio and RTV equipment
- Clause 02C: Inclusion of Road Carrier's Liability Insurance for the transportation of computers, computer accessories and components
- Clause 03A: Inclusion of Road Carrier's Liability Insurance for the transportation of alcohol
- Clause 03B: Inclusion of Road Carrier's Liability Insurance for the transportation of tobacco wares
- Clause 04: Inclusion of Road Carrier's Liability Insurance for the transportation of containers in the international traffic
- Sublimit: 5 000.00 EUR for one occurrence and 10 000.00 EUR for all occurrences
- Clause 05: Inclusion of Road Carrier's Liability Insurance for the transportation of cosmetics
- Clause 07: Inclusion of Road Carrier's Liability Insurance for the transportation in countries associated with increased transportation risk in the international traffic
- deductible franchise for every occurrence: 500 EUR
- Clause 08A: Inclusion of Road Carrier's Liability Insurance for commissioned actions of lading and/or unloading in the international traffic
- Sublimit: 20 000.00 USD for one occurrence
- Clause 08B: Inclusion of Road Carrier's Liability Insurance for damages in the transported commodities, arising from actions undertaken to secure the commodities

- Clause 10: Inclusion of Road Carrier's Liability Insurance for the transportation of motor vehicles
- deductible franchise 10%: of value of the loss, no less than 400 EUR for each transported vehicle
- Clause 11: Inclusion of Road Carrier's Liability Insurance for the transportation of tyres and car components
- deductible franchise for every occurrence for the aforementioned clauses: 400 EUR
- Clause 13: Inclusion of Road Carrier's Liability Insurance for the transportation of commodities with controlled temperature of the transportation
- deductible franchise for every occurrence: 10% of the loss value, not less than 400 EUR

Territorial scope of the outside the territory of the Republic of Poland, including insurance: countries associated with increased transportation risk, under the provisions of Clause 07
